POOL RULES

Excerpted and Compiled from House Rules adopted 2016

Club facilities are reserved for the exclusive use of Lodge Members, family members, Associate Members and their bona fide guests at all times. The pool area, including the barbecue pavilion, is open, weather permitting, daily and on weekends from approximately 10:00 a.m. until one hour before the closing time of the Lounge, except for scheduled maintenance or when reserved for activities approved by the Board of Governors.

Admission fees of one dollar (\$1.00) per person must be paid by all Members and guests upon arrival, whether swimming or not. Fees may be paid at the Golf Shop or the Lounge window. Failure to do so will result in a suspension of privileges, including beverage service, and create indebtedness to the Club that must be satisfied by the Member before service can be restored. Members are responsible for the payment of any bills or fees incurred but not paid by their guest(s).

- 1. Safety is of paramount importance. Members and guests will observe the following safety rules at all times:
 - a. No running or horseplay in the pool area;
 - b. No diving or jumping into water less than 5 feet deep;
 - c. No sitting or standing on, or diving or jumping from lifeguard chairs;
 - d. No open sores or cuts in the pool;
 - e. Do not remove safety equipment from the pool area; and
 - f. The pool shall be vacated during electrical storms.
- 2. Absolutely no beverages of any kind may be brought into the pool area at any time except those purchased from the Golf Shop or the Lounge. NO GLASS CONTAINERS IN THE POOL AREA!
- 3. The minor children (under the age of 21) of a Member may not use pool facilities unless the Member or their spouse is present, except those children over 16 who have a valid driver's license and independent transportation. Use of the pool area is not extended to Members' adult children (over the age of 21) or their families.
- 4. Members and their families are limited to hosting no more than twenty-five (25) guests at a time without prior approval by the Board of Governors. This is to ensure that there is adequate service staff available and to avoid overcrowding of the pool and pool area. Use of the pool area may be restricted when large numbers of people are present.
- 5. Food may be cooked outdoors on the grills provided except when the kitchen is open. No hibachis or other charcoal-burning grilles may be brought onto the premises.
- 6. The barbecue pavilion is for the use of everyone in the pool area and should not be monopolized by any Member or party. Every effort should be made to share the grills and tables in and around the pavilion, and to vacate them in a timely manner when someone else wants to use them.
- 7. Members and guests using the pavilion will ensure that it is left clean for others' use and that all lights and grills are turned off and gas connections closed before departure.
- 8. Unaffiliated Elks and Members whose Club privileges have been suspended, as well as their spouses and family members, are not permitted to use Lodge or Club facilities, and may not be guests of a Member in good standing in the pool area.

POOL WEAR MUST BE COVERED INSIDE THE BUILDING! Shirts and shoes must be worn inside.

Members and guests are not allowed into the kitchen, and are not permitted to use the kitchen for personal cooking or storage. Kitchen utensils, including pots, pans, trays, etc., appliances and other kitchen equipment are not for personal use and may not be removed from the kitchen or the premises without permission of the Board of Governors.

Members may not purchase alcoholic beverages for other patrons, including Members, who have been denied service by a bartender. Doing so or attempting to do so can result in disciplinary action.

When requested, Members must present their membership card and family members must present their Identification Card in order to use any Club facilities. Members must attend to their guests at all times, and guests must depart the Social Quarters when the host Member or family member leaves.

It is a violation of Lodge policy and Grand Lodge Statutes for anyone to lend their membership card, I dentification Card and/or key card to another person for any purpose. Doing so will subject the offender to disciplinary action.
